WHAT DOES STOCKPILE DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Checking account and/or credit/debit card information
- IP address, browser type, and operating system. We accomplish this through the use of “cookies”. No personal information is stored in our cookies. For more information about cookies and how to disable them please visit <http://www.allaboutcookies.org>

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Stockpile chooses to share; and whether you can limit this sharing.

For nonaffiliates to market to you	No.	We don’t share.

What we do

How does Stockpile protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>When you access our Account holder areas, you are required to provide your user name and your password. Do not share your password and change it frequently.</p>
How does Stockpile collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ■ open an account ■ provide account information ■ direct us to sell securities ■ direct us to buy securities <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes—information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	<p>Pick either:</p> <ul style="list-style-type: none"> ■ "Your choices will apply to everyone on your account" or ■ "Your choices will apply to everyone on your account unless you tell us otherwise"
Use of Google Analytics?	<p>We use cookies to collect data through the use of Google Analytics.</p> <p>For more information reference "How Google uses data when you use our partners' sites or apps" located at: www.google.com/policies/privacy/partners/</p>

Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ Our affiliates include financial companies such as Stockpile Investments, Inc., and nonfinancial companies, such as Stockpile, Inc.
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> ■ Stockpile does not share with nonaffiliates so they can market to you.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
